- i. **"Agreement"** refers to these end user terms and conditions.
- ii. **“Personal Data”** means any personal data provided by You, on our behalf or on behalf of your customers.
- iii. **“Software”** means the WSISIGN [**KINGtouch**] software solution that is licensed to You pursuant to this EULA comprised of (a) all of the contents of the files, disk(s), USB, CD-ROM(s) or other media (including electronic media) with which this Agreement is provided or that can be accessed after acceptance of this License, or such contents as are hosted by WSISIGN or its distributors, resellers, or other business partners (collectively “Authorized Partner(s)”), including but not limited to (i) WSISIGN or third party computer information or software, and the [**KINGtouch**] application binary and/or bytecode software program; (ii) related explanatory materials in printed, electronic, or online form (“Documentation”); and (b) upgrades, modified or subsequent versions and updates (collectively “Updates”), and Software, if any, licensed to you by WSISIGN or an Authorized Partner as part of a maintenance contract.
- iv. **"Use" or "Using"** means to access, install, download, copy or otherwise benefit from using the Software solely in connection with the Elo TouchSystems touchcomputer accompanying the Software.
- v. **"Device"** means a server that is owned and controlled by You and which has been authenticated for use with the Software; provided that the number of Devices shall not

exceed one.

- vi. **"You"** refers to the entity that issued a Purchase Order for the Software, and who obtains, uses or installs the Software.

2. LICENSE

(a) Grant. Subject to the terms and conditions herein, WSISIGN grants You a personal, revocable, non-exclusive, non-transferable license to install and Use the Software in machine-readable form on one designated server that is owned or controlled by You only for the purposes described in the Documentation and solely for use with the Elo TouchSystems touchcomputer with which Software was distributed.

(b) Restrictions. You may not sell, resell, lease, sublicense, rent, redistribute or otherwise transfer or assign the Software. This Agreement does not imply any rights to future upgrades or updates of the Software. However, if WSISIGN does provide You with any upgrades or updates to the Software, such upgrades or updates shall be subject to the terms and conditions of this Agreement or any agreement which accompanies such upgrades or updates, and may be subject to additional payments. You also acknowledge that the Elo logo and Elo TouchSystems trademark are trademarks of a WSISIGN Authorized Partner. You have no rights to modify or otherwise obscure any trademarks provided as part of or resulting from this Software or its operation on the Elo TouchSystems touchcomputer.

Upon WSISIGN's written request, no more than once per calendar year, You shall furnish WSISIGN with a signed certification listing the locations and designated servers on which the Software runs. WSISIGN may, not more than once per year and at its own expense, audit Your compliance with the requirements of this Agreement. Any such audit shall be conducted during regular business hours and shall not unreasonably interfere with Your business activities. If an audit reveals that You have underpaid License fees to WSISIGN, then You shall be invoiced for such underpaid fees at WSISIGN's then-current prices for the Licenses, plus twenty-five percent (25%).

9. UPDATES AND UPGRADES

Customers with valid maintenance contracts may receive updates and upgrades to current versions of software at no additional charge.

Customers without a valid maintenance contract may receive bug fixes at no charge, provided that the customer is using the current major version of the software. E.g. Version 2.X.

Updates and upgrades for customers outside of a maintenance contract are as follows:

- i. Upgrades are available at 50% of the retail price of a full **[KINGtouch]** license fee, provided that the customer is upgrading from one major version to another e.g. Version 2.X to Version 3.X
- ii. Updates are available at 20% of the retail price of a full **[KINGtouch]** license fee, provided that the customer is using the current major version of the software. E.g. Version 2.X

10. GENERAL

(a) Force Majeure. Notwithstanding any other provision of this Agreement, neither party shall be deemed in default of this Agreement for failure to fulfill its obligations when due to causes beyond its reasonable control (including without limitation, if a third party distribution agent ceases to provide airtime, internet or other similar services to WSISIGN at all or on commercially reasonable terms). This provision shall not be construed as excusing non-performance of any obligation by either party to make payment to the other party under this Agreement.

(b) Waiver, Survival and Severability. Waiver by either party of any default by the other party shall not be deemed a continuing waiver of such default or a waiver of any other default. The terms, conditions and warranties contained in this Agreement that by their sense and context are intended to survive the performance hereof by either or both parties shall so survive the completion of performance, cancellation or termination of this Agreement. If a provision of this Agreement is held to be invalid or unenforceable, such invalidity or unenforceability shall not invalidate or render unenforceable the entire Agreement, but rather the entire Agreement shall be construed as if not containing the particular invalid or unenforceable provision or provisions and the rights and obligations of each party shall be construed and enforced accordingly.

(c) Governing Law. This Agreement shall be governed by the laws of Ontario and the federal laws of Canada applicable therein, without regard to conflicts of law provisions, and you hereby consent to the exclusive jurisdiction of the courts in Ontario, Canada. The application of the United Nations Convention on Contracts for the International Sale of Goods to this License is expressly excluded.

(d) Assignment. WSISIGN may assign this Agreement without notice to You. You shall not assign this Agreement.

(e) Notices. All notices or other communications under this Agreement shall be deemed to have been duly given when made in writing and delivered in person, by courier or deposited in the mail, return receipt requested and addressed to You at the billing address supplied to WSISIGN or the third party distribution agent by You, or addressed to WSISIGN at info@wsisign.com. In addition to the foregoing, WSISIGN may, at its option, give You any notice under this Agreement by email or posting communications concerning this Agreement on its Site. Notice to You by email shall be deemed to have been duly given when transmitted to an email address furnished by You to WSISIGN.

(f) Privacy. WSISIGN's Privacy Policy, located at www.wsisign.com/privacypolicy.html explains how WSISIGN Systems Ltd. treats your information and protects your privacy when you use the Software. You agree to the use of your data in accordance with WSISIGN's privacy policies.

(g) Entire Agreement. This Agreement constitutes the entire agreement between the parties respecting the Software and there are no provisions, representations or collateral agreements between the parties other than as set out in this Agreement. If you are using the Software in Your capacity as an employee of an entity that has purchase an enterprise license from WSISIGN, then additional terms may apply.
